# Eligibility for Deputation (Including Short Term Contract):

Officers under the Central Government or State Governments or Union Territories or Public Sector Undertakings or Recognised Research Institutions or Autonomous bodies -

- (a)(i) holding analogous posts on regular basis; or
- (ii) having five years service rendered after appointment thereto on a regular basis in the scale of pay of Rs. 8000-13500/- in the parent cadre or Department.
- (b) Possessing educational qualifications and experience prescribed for direct recruits, which are as follows:

## Essential educational qualifications for direct recruits:-

- (i) Bachelor's Degree in Veterinary Science and Animal Husbandry from a recognized University or Veterinary Institute or equivalent as mentioned in Schedule-I or Schedule-II of the Indian Veterinary Council Act, 1984.
- (ii) Should have registered with Veterinary Council of India or State Veterinary Council.
- (iii) Post Graduate Degree in any branch of Poultry Science or Animal Genetics and Breeding or Animal Nutrition or Animal Production and Management from a recognized University or Institute or equivalent.
- (iv) Five years experience in management of large size poultry farm.

**Note 1–** Qualifications are relaxable at the discretion of the Union Public Service Commission in case of candidates otherwise well qualified.
