11	With respect to the sale of bull calves by the Ministry of Animal Husbandry, Dairying and Fisheries, kindly mention the guidelines pertaining to their sale, if any. Documents to show what happens to the profits/proceeds generated. There form, if any.	The bull calves are sold to states/Livestock Development Board/Semen Banks/Gaushalas/Private Breeders/Farmers to improve cattle germ plasm in their possession. This organization is selling bull calves at Book value fixed by Ministry depending on age of bull calves and Dam's yield. Currently the Book value is fixed based on Ministry's letter No. F.No. 6-17/2001-AHT(NPCBB) dated 29 th April, 2005(Copy enclosed). In regards to documents pertaining to profits or proceeds generated, is concerned it is to state that the amount received towards sale of animals is being deposited in Govt. receipt account.
12	With respect to the central cattle breeding farms, documents to show who are the bred animals given to along with data pertaining to the same.	The query is incomplete and vague wheeb makes it difficult to comprehend and hence unable to be answered.
