**Subject: - Release of Central Assistance of Rs. 49,64,000/- (Rupees Forty Nine Lakhs and Sixty Four Thousand Only) as Ist installment out of total sanctioned amount of Rs. 200.00 Lakhs during 2017-18 under National Livestock Mission for the State of Bihar**

Sir,

I am directed to convey the sanction of the President of India for the payment of Grants-in-aid amounting to **Rs. 49,64,000/- (Rupees Forty Nine Lakhs and Sixty Four Thousand Only)** as Ist installment out of total sanctioned amount of **Rs. 200.00 Lakhs** during 2017-18 in favour of State Government of Bihar, Department of Animal Husbandry under MH-3601 (General) under National Livestock Mission Scheme for implementation of various components as detailed in **Annexure** during 2017-18 in the State.

2. The programme is to be implemented during 2017-18 on the following terms and conditions.

- (a) Central Grant is sanctioned on the condition that this will be utilized for specific purpose and places / projects as per the proposal submitted by the State Government vide their letter 10 Ni (NLM) 01/2017-3122 (Ni) dated 26.09.2017 from Secretary, Department of Animal and Fisheries Resources, Govt. of Bihar. The Government of Bihar would arrange matching share for each component as mentioned (as per the guidelines of the scheme) during 2017-18.
- (b) The estimated expenditure is to be treated as maximum and all efforts will be made to effect as much economy as possible without deterioration of the scheme and also that the expenditure incurred within the ceiling approved by the Government of India.
- (c) The State Government of Bihar will maintain proper account of expenditure incurred and submit the statement of the audited accounts to the Government of India in due course.

- (d) In terms of relevant rule of General Financial Rules, 2017 the account of Grantee Institutions or organization shall be open to inspections by the sanctioning authority and audit both by the Controller and Auditor General of India and under the provision of CAG (DPC), 1971 and under audit by the Principal Accounts Officer of the Department, whenever the Institution/Organization call to do so. The State Government/Grantee organization shall submit an audited certificate of actually utilization grants in-aid sanctioned in prescribed Proforma as per GFR, 2017 specifying report on targets and achievements cum performance report to the sanctioning Authority.
- (e) The account of grant shall be opened to check test by the Comptroller and Auditor General of India at his discretion.
- (f) The proposal will be implemented by the State Government strictly as per the guidelines contained in the scheme, conditions laid down in administrative approval issued by this department's letter vide No. 2-47/2009-AHT/FF-NLM Vol.III dated 25.04.2017 such as women beneficiaries, etc. and as per the proposal approved by this Department.
- (g) The purchase of items may be done following General Financial Rules (GFR)/Store purchase rules.
- (h) No double benefit be provided to a farmer under the components.
3. The expenditure of **Rs. 49,64,000/- (Rupees Forty Nine Lakhs and Sixty Four Thousand Only)** shown in para 1 above, may be debited to the following head of account:

The State Government will utilize the fund for the scheme for which this amount is released and submit the utilization certificate, statement of expenditure and physical progress in stipulated format through Administrative Head to this Ministry in due course as per guidelines for release of balance funds.
5. There are no unspent balances of any previous un-revalidated amount of last year and if there are unspent balances of previous years, the same may be adjusted towards future releases.
6. The State & UTs will mandatorily source germplasm/Animals/Day old chicks/Hatching eggs etc from Government organizations including ICAR and Universities as mentioned in the NLM guidelines. If the Government organizations including ICAR and



Universities certify that the above organizations are unable to supply then only it should be sourced from private organizations strictly following the GFRs.

7. This issues under the delegated powers and with the concurrence of Integrated Finance Division of this Ministry vide their Dy. No. 6666/AS&FA dated 23.03.2018.

8. This has been noted as per GFR, 2017 at S.No. 80 of Pg. No.16 of the Register of Grants under National Livestock Mission for 2017-18.
