I am directed to convey the sanction of the President of India for the payment of Grants-in-aid amounting to Rs.1, 73, 70,000/- (Rupees One Grore Seventy Three Lakh and Seventy Thousand Only) to Government of Telangana, Department of Animal Husbandry under MH-3601 (SCSP) under National Livestock Mission Scheme for implementation of various components as detailed in Annexure during 2017-18 in the State.

- The programme is to be implemented during 2017-18 on the following terms and conditions.
- (a) Central Grant is sanctioned on the condition that this will be utilized for specific purpose and places / projects as per the proposal submitted by the State Government vide their letter  $804/\mathrm{AH}(3)/2017$  dated 24.04.2017 from Principal Secretary, Animal Husbandry, Dairying & Fisheries (AH2) Department, Government of Telangana, Hyderabad.
- (b) The Government of Telangana would arrange matching share for each component as mentioned (as per the guidelines of the scheme) during 2017-18.
- (c) The estimated expenditure is to be treated as maximum and all efforts will be made to effect as much economy as possible without deterioration of the scheme and also that the expenditure incurred within the ceiling approved by the Government of India.
- (d) The State Government of Telangana will maintain proper account of expenditure incurred and submit the statement of the audited accounts to the Government of India in due course. Sharm fra heal

- (e) In terms of relevant rule of General Financial Rules, 2017 the account of Grantee institutions or organization shall be open to inspections by the sanctioning authority and audit both by the Controller and Auditor General of India and under the provision of CAG (DPC), 1971 and under audit by the Principal Account Officer of the Department, whenever the Institution/Organization call to do so. The State Government/Grantee organization shall submit an audited certificate of actually utilization grants in-aid sanctioned in prescribed Proforma as per GFR, 2017 specifying report on targets and achievements cum performance report to the sanctioning Authority.
- (f) The account of grant shall be opened to check test by the Comptroller and Auditor General of India at his discretion.
- (g) The proposal will be implemented by the State Government strictly as per the guidelines contained in the scheme, conditions laid down in administrative approval issued by this department's vide letter No. 2-47/2009-AHT/FF-NLM Vol.III dated 25.04.2017 such as women beneficiaries, etc. and as per the proposal approved by this Department.
- (h) The purchase of items may be done following General Financial Rules 2017 (GFR)/Store purchase rules.
- (i) No double benefit be provided to a farmer under the components.
- 3. The expenditure of Rs.1, 73, 70, 000/- (Rupees One Crore Seventy Three Lakh and Seventy Thousand Only) shown in para 1 above, may be debited to the following head of account:

- 4. The State Government will utilize the fund for the scheme for which this amount is released and submit the utilization certificate, statement of expenditure and physical progress in stipulated format through Administrative Head to this Ministry in due course as per guidelines for release of balance funds.
- 5. There are no unspent balances of any previous un-revalidated amount of last year and if there are unspent balances of previous years, the same may be adjusted towards future releases.
- 6. The State & UTs will mandatorily source germplasm/Animals/Day old chicks/ Hatching eggs etc from Government organizations including ICAR and Universities as mentioned in the NLM guidelines. If the Government organizations including ICAR and Universities are unable to supply then only it should be sourced from private organizations strictly following the GFRs. Tharm baken
