- 2. The programme is to be implemented on the following terms and conditions.
 - a. The State Government/Grantee organization shall submit an audited certificate of actually utilization grants in-aid sanctioned in prescribed Performa as per GFR, 2017 specifying report on targets and achievements cum performance report to the sanctioning Authority.
- f. The proposal will be implemented by the State Government strictly as per the guidelines contained in the scheme, conditions laid down in administrative approval issued by this department's vide letter No. 2-47/2009-AHT/FF-NLM Vol.III dated 25.04.2017 such as women beneficiaries, etc. and as per the proposal approved by this Department.
- g. The purchase of items may be done following General Financial Rules (GFR)/Store purchase rules.
- h. No double benefit will be provided to a farmer under the components.
- 3. The expenditure of Rs. 4.65764 Lakhs shown in para 1 above, may be debited to the following head of account:
