Promotion:

Upper Division Clerk in Level-4 (Rs. 25,500-Rs. 81,100) of the Pay Matrix with eight years regular service in the grade and have qualified the training in Cash and Accounts work conducted by Institute of Secretariat Training & Management or equivalent.

Note: Where juniors who have completed their qualifying/eligibility service are being considered for promotion, their seniors would also be considered provided they are not short of requisite qualifying/ eligibility service by more than half of such qualifying/ eligibility service, or two years, whichever is less, and have successfully completed their probation period for promotion to the next higher grade along with their juniors who have already completed such qualifying/ eligibility service.

Deputation:

Officers under the Central Government:

- a) (i) holding analogous post on a regular basis in the parent cadre/ department or
- (ii) with 6 years' service in the grade rendered after appointment on a regular basis in in Level-5 (Rs. 29,200-Rs. 92,300) or equivalent in the parent cadre/department; or
- (ii) with 8 years' service in the grade rendered after appointment thereto on a regular basis in Level-4 (Rs. 25,500-Rs. 81,100) or equivalent in the parent cadre/department; and
- b) who have undergone training in cash and accounts work in the ISTM or equivalent course and possessing two years' experience of cash, accounts and budget work.

(The Departmental officers in the feeder category who are in the direct line of promotion shall not be eligible for consideration for appointment on deputation. Similarly, deputationists shall not be eligible for consideration for appointment by promotion.)

(Period of deputation including period of deputation in another ex-cadre post held immediately preceding this appointment in the same or some other organization/ department of the Central Govt. shall ordinarily not to exceed 3 years. The maximum age limit for appointment by deputation shall not be, not exceeding 56 years, as on the closing date of receipt of application.)
