Composite Method : Deputation (including short term contract) / Promotion : Officers holding the post of Stenographer under the Central Government or State Government or Union territories or Agricultural Universities or recognised research Institutes or Councils or Semi Government or autonomous bodies and statutory organisations:-

- (a) (i) holding analogous post on regular basis in the parent cadre or Department or
(ii) with ten years service in the grade rendered after appointment thereto on a regular basis in Level 4 (Rs.25,500 – 81,100) in the pay matrix or equivalent in the parent cadre or department ;

Note1.- The departmental stenographer Grade II in Level 4 (Rs.25,500 – 81,100) in the pay matrix with 10 years regular service in the grade shall also be considered along with outsiders and in case he or she is selected for appointment to the post, the same shall be deemed to have been filled by promotion.

Note2.- The departmental officers in the feeder category who are in the direct line of promotion shall not be eligible for consideration for appointment on deputation and similarly deputationist shall not be eligible for consideration for appointment by promotion.

Note3. - The period of deputation (including short term contract in another *ex-cadre* post held immediately preceding this appointment in the same or some other organisation or department of the Central Government shall ordinarily not exceed three years.

Note. - The maximum age limit for appointment by deputation (including short term contract) shall be not exceeding fifty six years as on the closing date of receipt of application.

Note5. - For the purpose of appointment on deputation basis, the service rendered on a regular basis by an officer prior to 1st January 2016 (the date from which the 7th CPC recommendation has been extended) shall be service rendered in the corresponding pay level extended based on the recommendations of the Pay Commission except where there has been merger or more than one pre-revised scale of pay.
