Promotion: Marketing Assistant in level 6 in pay matrix (Rs.35,400-1,12,400/-) with five years' regular service in the grade.

Note.- where juniors who have completed their qualifying or eligibility service are being considered for promotion, their seniors would also be considered provided they are not short of the requisite qualifying or eligibility service by more than half of such qualifying or eligibility service or two years, whichever is less, and have successfully completed their probation period for promotion to the next higher grade alongwith their juniors who have already completed such qualifying or eligibility service.

Deputation:

Officers under the Central Government or State Government or Union territories :

(a) (i) holding analogous post on regular basis in the parent cadre or Department or

(ii) with five years service in the grade rendered after appointment thereto on a regular basis in level 6 in the pay matrix(Rs.35,400-1,12,400/-) or equivalent in the parent cadre or Department : or

(b) possessing the following educational qualifications and experience :

Essential:

(i) Bachelor's degree in Zoology or Fishery Science or Industrial Fisheries or Home Science of a recognized University or equivalent and

(ii) Two years' practical experience in fishery development or food products including fishing and marketing of fish

Desirable : Diploma in Marketing or Business Management or MBA in Marketing Management

(The Departmental Officers in the feeder category who are in the direct line of promotion, shall not be eligible for consideration for appointment on deputation. Similarly deputationist shall not be eligible for consideration for appointment by promotion.

The period of deputation including the period of deputation in another *ex-cadre* post held immediately preceding this appointment in the same or some other organizations or department of the Central Government shall not exceed three years. The maximum age limit for appointment by deputation shall be not exceeding fifty six years as on the closing date of receipt of applications).
