- I. The consultant will not be entitled for any kind of allowances and residential accommodation. They will also not be entitled to residential telephone facilities, transport facilities except Transport Allowance as approved by the Department and staff car.
- II. The engagement of the Consultant will be purely on Contract basis.

- III. The engagement period for the consultant would **initially be for a period of one year**. This period may be extended or curtailed subject to review of performance at the sole discretion of this Department. The candidate should not have age above 65 years as on 01.01.2022.
- IV.The Consultant will be eligible for 08 days leave during a calendar year. This leave will not be carried forward in case the engagement period is extended by this Department. Also, no payment in lieu of un-utilized leaves will be paid by this Department at the time of expiry of contract.
- V. The candidate will be required to sign a non-disclosure undertaking and declaration for abiding by the Code of Integrity for Public Procurement (CIPP).
- VI. The Department may terminate the services of Consultants in case he/she is unable to achieve the assigned target within the time-frame or the work assigned to him/her is not satisfactory to the Department or he/she is found to be lacking in honesty and integrity.
- VII. The Department shall also reserve the right to terminate the services of Consultants at any time without giving any notice and also without assigning any reason. The engagement of consultants will not confer any right on the part of individual for permanent appointment to the post
- VIII. The Consultants may be called to the Office on Saturdays, Sundays and other Gazetted Holidays or may be asked to sit late in the office after office hours, in case of exigency of work. No extra allowances will be permissible for the same.
