GENERAL TERMS AND CONDITIONS

- The contractual appointment will be attached in Department of Fisheries located in New Delhi. The applicant should have retired from Central Govt. Ministries/Departments located in New Delhi, having experience in either of the Establishment/International Cooperation/Vigilance/General Administration/Parliament. He/ She may preferably be a resident of Delhi only.
- 2. The consultant will not be entitled for any kind of allowances and residential accommodation. They will also not be entitled to telephone facilities, transport facilities and staff car.

- 12. If any declaration given or information furnished by the candidate proves to be false or if the candidate is found to have willfully suppressed any material information, he will be liable for removal from engagement service and such other action as Government may deem necessary.
