I am directed to say that one post of Senior Technical Assistant (Fisheries) in Level-7 of the Pay Matrix (Pay Band-2 Rs. 9300-34800 plus Grade Pay of Rs. 4600 ,pre-revised) in the Department of Fisheries, Ministry of Fisheries, Animal Husbandry and Dairying, Krishi Bhawan, New Delhi is proposed to be filled up on Composite Method [Deputation (including Short Term Contract) Plus Promotion] from amongst the Officers of the Central or State or UT Administration or Autonomous bodies or recognised Research Institute or Universities or Statutory Bodies:-

- a. (i) holding analogous post on regular basis in the parent cadre or Department; or
(ii) Five years' regular service in the grade rendered after appointment thereto in the scale of pay of PB-2 Rs. 9300-34800 with Grade pay of Rs. 4200 or equivalent in the parent cadre or Department, or
Ten years' regular service in the grade rendered after appointment in the scale of pay of PB-1 Rs. 5200-20200 with Grade Pay of Rs. 2800 or equivalent in the parent cadre or department; and
- b. possessing the following educational qualifications and experience:

Essential:

- a. Master's Degree in Zoology with specialization in Fisheries; or M.F.Sc. or M.Sc. in Marine Biology or M.Sc. in Industrial Fisheries or M.Sc. in Aquaculture or M.Sc. in Fisheries Science from a recognised University or Institute.
- b. Two years experience in Fisheries Research or work experience in the field of Fisheries (inland or Marine or Aquaculture) from a Central or State Government Department or Public Sector Undertaking or Recognised Research Institute or semi-Government or Statutory or Autonomous Organization or Private Sector.

Note: The Departmental Fisheries Research Investigator (Ordinary Grade) in the scale of pay of PB-1, Rs. 5200-20200 with Grade Pay of Rs. 2800 with ten years regular service will also be considered along with outsiders. If the Departmental candidate is selected for appointment to the post, the same shall be deemed to have been filled by promotion.

Note 1: The departmental officers in the feeder category who are in the direct line of promotion will not be eligible for consideration for appointment on deputation. Similarly, deputationist shall not be eligible for consideration for appointment by promotion. (Period of deputation (ISTC) including period of

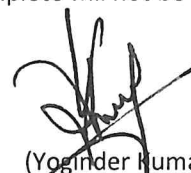

The maximum age limit for appointment by deputation(including short term contract) shall be not exceeding 56 years as on the closing date for receipt of applications).
