- (ii) with two years' service in the grade rendered after appointment thereto on regular basis in Level 09 (R 53100-167800) in the Pay Matrix or equivalent in the parent cadre or department; or,
- (iii) With four years' service in the grade rendered after appointment thereto on regular basis in posts in Level-8 (Rs. 47600-151100) in the Pay Matrix or equivalent in the parent cadre or department; or,
- (iv) with five years' service in the grade rendered after appointment thereto on regular basis in posts in level-7 (Rs. 44900-142400) in the Pay Matrix or equivalent in the parent cadre or department; and,
- (b) Possessing the following educational qualifications and experience:
- (i) Masters degree in Zoology with specialisation in Fisheries or Master of Fisheries Science or M.Sc. in Marine Biology or M.Sc. in Industrial Fisheries or M.Sc. in Aquaculture or Master of Science in Fisheries Science from a Recognised University or Institute.
- (ii) Three years experience in the field of Fisheries development including policy and planning, formulation and technical evaluation of plan schemes, their monitoring and implementation from a Central or State Government or Union territory Administration department or Public Sector Undertaking or Recognised University or Research Institute or Statutory or Autonomous organisation

Note 1: The departmental Officers in the feeder category who are in the direct line of promotion shall not be eligible for consideration for appointment on deputation. Similarly, deputationists shall not be eligible for consideration for appointment by promotion.

Note 2: The Period of deputation (including short term contract) including the period of deputation (including short term contract) in another ex-cadre post held immediately preceding this appointment in the same or some other organisation/department of the Central Government shall ordinarily not exceed three years. The maximum age limit for appointment on deputation shall be not exceed fifty-six years as on the last date of receipt of applications
