- Renewal of Memorandum of Understanding (MoU) between Government of India and Government of the People's Republic of Bangladesh was carried out in the presence of Hon'ble Prime Minister of India on co-operation in the field of fisheries during the visit of Prime Minister of Bangladesh, Her Excellency Sheikh Hasina to India on 22nd June 2024.
- 2. Hon'ble Minister Shri Rajiv Ranjan Singh took charge of the Ministry of Fisheries, Animal Husbandry and Dairying alongwith Hon'ble Ministers of State Prof. S. P. Singh Baghel and Shri. George Kurian. The Hon'ble Ministers were welcomed by Department of Fisheries and Department of Animal Husbandry and Dairying Secretaries and other senior officials. Addressing the media after taking charge, the Hon'ble Ministers said that there will be continuity in implementation of the vision and policies of the earlier Governments led by Hon'ble Prime Minister, Shri. - 24. The Coastal Aquaculture Authority (CAA) processed 234 applications including 163 applications for registration and renewal of registration received from the States/ Union Territories of Tamil Nadu, Andhra Pradesh, Gujarat, Odisha, Karnataka and Kerala and 71 applications for the issuance of Certificate of Compliance for Antibiotic Free Aqua Inputs received from the input manufacturers. 752 visits were made to the farms and hatcheries and sensitize the Fisheries Officers, farmers, hatchery operators and other stakeholders of Tamil Nadu, Andhra Pradesh, Puducherry and Goa on the CAA (Amendment) Act, Rules and Guidelines.
- 25. The Central Institute of Coastal Engineering for Fishery (CICEF) Prepared and submitted Techno-Economic Feasibility Reports (TEFR) for the modernization and upgradation of Vanakbara Fishing Harbour in the Union Territory (UT) Administration of Dadra and Nagar Haveli (DNH) and Daman and Diu, and Karaikal Fishery Harbour Stage II in the UT of Puducherry, incorporating elements of smart, intelligent, blue ports, green ports, and other components of a smart and integrated Fishing Harbour.
- 26. The National Institute of Fisheries Post Harvest Technology and Training (NIFPHATT) conducted training programme on post-harvest management for 31 marine fisher women/men.
- 27. The Grievance disposal under the CPGRAMS Portal for Department of Fisheries stood at 95% as on 30th June, 2024.
